2. CUSTOMER'S INDENTIFICATION:

Customers must make available copy of their photo ID.

3. DANGEROUS GOODS.

The following dangerous materials are not acceptable for shipment: explosive material (ammunition, firework, distress signals, smoke signals...), compressed gas (camping stoves, aerosols....),flammable (matches, lighters, paints, varnish, petrol...) corrosive and oxidizing material, bleach, wet batteries, mercury (e.g. in thermometer and barometer),sodium.., toxic material, radioactive material, household goods such as paints, aerosols ,bleaching powder, chlorine.

4. EMBARGO:

Textile, bags, furniture and shoes are forbidden into Nigeria. Shipment of these materials is at the senders or owners

risk.

5. CUSTOMS.

All export shipments are subject to custom check/inspection both in the United States and overseas .Prinaj Services Inc. take no responsibility for any export shipment that is put on hold or ceased by either U.S or overseas customs.

6. LOSS/DAMAGE ITEMS.

Export shipments are usually carried as cargo through airfreight and subject to "at air" condition and airline cargo shed handling. Prinaj Services takes no responsibility for any damage items during airport transit but shall make efforts to trace loss/damaged item on the export shipment and ensure adequate compensation from the Airline.

7. DELIVERY TIME:

We guarantee delivery of export shipment within one week from the time the consignment leave the United States. However, depending on the volume of cargo received by the Carrier (Airline) for shipment and custom inspection, there may be delay of some days or weeks before the consignment arrives at the final destination.
